I met with the complaint in this case at [REDACTED] Ave [REDACTED]. He is the owner of [REDACTED] Ave where the subject resides. he stated the subject [REDACTED] had rented the ground floor apartment and moved away approximately one month ago. Subjects had left her dog in the apartment but was coming back to feed it. The owner stated he had not seen anyone at the apartment for the last ten days. Through an open window I viewed the apartment and saw no sign of food or water. The furnishings in the apartment were ripped and torn with feces and urine through the apartment. The owner signed a permission to enter form and along with Animal Rescue I entered and removed the dog. Intake # [REDACTED] dog placed on hold for HLE. A Notice To Comply was taped to the door informing subjects of the seizure and how to contact the undersigned. Dog removed to Brooklyn Shelter with a request for a vet statement.
