Dear Ms. [Redacted],

On January 29th., [Redacted], Rt. 20
[Redacted] N.Y., a breeder of Brittany Spaniels, was arrested and charged
by this Agency on a single count of violating section 353 of the New
York State Agriculture and Markets Law relating to Cruelty to Animals.
Mr. [Redacted] was charged specifically with failing to provide proper food,
water and sustenance to thirteen (13) Brittanys' chained and caged in
the rear yard of his home.

On [Redacted], a jury trial was held in the Town Court, Town
of [Redacted], with a guilty verdict being rendered on the charge specified,
that is, Section 353, Failure to Provide Proper Food, Water and Susten-
ance. Subsequently, a notice of appeal was filed on May 17th., [Redacted]
appealing from the judgement of the Town Court. However, no further
steps to perfect the appeal were taken and on September 21st., [Redacted]
[Redacted] County Court Judge [Redacted] rendered his decision dismissin
the appeal and allowing the original conviction to stand.

Enclosed is a copy of Judge [Redacted] Decision and Order of the Court.
This Agency is requesting that whatever revocation of privileges with
the AKC and/or breeders certificates that might be imposed against Mr.
Kuhn be so applied. This Agency also has on file, other complaints by
purchaser's of Mr. [Redacted] dogs specifying dissatisfaction with the health
and temperament of the animals. Details will be made available should you
so request.
