to euthanize any of said animals which have been certified by
a veterinarian surgeon, duly licensed by the state of New York,
in writing, to be so injured, diseased, disabled, or infirmed
as to be unfit for any useful purpose, which said animals
said veterinary surgeon believes to be suffering pain or
serious discomfort. Said euthanization to be preferred in
accordance with accepted humane means and procedures.
