In support of your deponent's assertion as to the existence of reasonable cause, the following facts are offered:

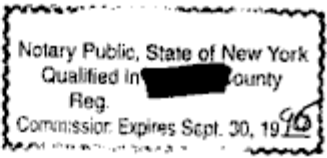
